Continia Software A/S was established in 2009, where an investor group took over selected products from Celenia Software. Continia Software A/S is a specialized ISV-company, a leading company in the “administrative” software solutions product range, which aims to streamline and automate administrative tasks in Microsoft Dynamics NAV.
